All students applying for summer financial aid must submit a 2012-13 Free Application for Federal Student Aid (FAFSA). Summer financial aid application information must be complete, including course name and title. Incomplete applications will not be processed. *The deadline to submit summer financial aid applications is **April 30, 2012**. Requests for summer financial aid received after the deadline will not be considered.*

Study Abroad Courses: Students enrolling in CCA-sponsored Study Abroad courses must complete the FAFSA by **Monday, February 20, 2012** and submit a *complete* summer aid application to the Financial Aid Office by **Monday, February 27th, 2012** for priority processing.

On-Campus Courses*: Students enrolling in on-campus CCA summer courses should complete the 2012-13 FAFSA by **Monday, March 12th** and submit a *complete* summer application by **Friday, March 16th, 2012**. Any applications submitted after **March 18th** cannot be guaranteed a timely award notification.

If you are selected for verification by the Department of Education, you must submit a completed **verification form and all supporting documents prior to receiving a finalized financial aid award for the 2012-13 academic year**. Federal Direct Loans received for Summer Session will count toward your aggregate borrowing maximum(s). Students completing their degree requirements in the summer will have Federal Direct Loan amounts prorated based on enrollment. Federal grant aid will be prorated to reflect summer enrollment. Scholarship eligibility is limited to students enrolled in at least 3 units of on-campus coursework applicable toward degree completion.
